Thank you for your question and comments.

The project design and permitting was completed in 2020, preceding the publication of the Climate Change Resiliency Strategy. Since the start of the project in 2011, design team has complied with the National Environmental Policy Act, including minimizing impacts to sensitive natural resources along the shoreline to the greatest extent possible. The design team was able to limit impacts to wetlands to approximately 0.07 acres, a third of which will be restored.

The shoreline of West Park is one of the few remaining vegetated shorelines within approximately 2,000 feet up or downstream of the S-32 Bridge. The on-site wetland along the shoreline of West Park consists of a low marsh with a vigorous growth of the native plant *Spartina alterniflora*. This low marsh area has successfully stabilized the shoreline along this part of the Shrewsbury River, and it is showing little sign of stress despite the severe tidal currents that occur within this portion of the river. The bulkhead was designed to minimize erosion of the shoreline, particularly around the bridge, in consideration of a severe, Sandy-like, storm event. The team's design efforts included minimizing disturbance to the existing living shoreline and have received NJDEP permit.

Thank you for your questions and comments from your prior submissions dated 11/7 and 11/13.

Existing trees in the north section of the West Park that will remain during construction will be protected by the placement of tree protection fencing at their drip line. There are also provisions for a certified tree expert to perform monitoring during construction and means for preventing soil compaction and structural damage to the remaining trees have been included in the construction documents. The contractor is required to de-compact any of the soil disturbed by the construction in West Park and return to existing conditions.

Improvements or enhancements to Sea Bright Park are not part of the construction scope since the bridge replacement occurs to the south and doesn't directly impact the park.

In response to your online submitted question regarding the bridge height clearance, the minimum bridge clearance over Mean High Water is 15'-0" in the closed position. Mean Low Water is reported as 3.51' lower (Elevation -2.0), thus the clearance is <u>approximately</u> 18'-6" at Mean Low Tide.

The bridge replacement project was designed and coordinated via a permit from the US Coast Guard (USCG). Under the permit provisions, the contractor is required to perform all work so that "free navigation of the waterway is not unreasonably interfered with and the present navigable depths are not impaired." Some construction activities may, with approval from the USCG, temporarily impact the navigation clearances for short-term durations. Under any such condition, the Project Team will communicate that to the public in advance.

At the Waterfront Park, the Borough installed a black metal fence that the fishing people complain is too high for them to cast and most importantly to retrieve their catch. I will take that up in a Borough Workshop.

What I wanted to ask at yesterday's meeting:

At the four locations that the bridge engages Rumson – 2 connections, and Sea Bright – 2 connections, is there any possibility to consider accommodation that Fishing would be practical?

It was mentioned in my discussion with the Contractor, that there will be a Bulkhead with some sort of railing as required by regulations.

Is there a way to make it Fishing Friendly at those 4 locations?

Fishing is typically more productive in close to a structure,, and so if they can gain access to those positions and the rail is not obstructing, the fishing afficionados would see it as Community Friendly.

Thank you for your comments and question. The suggestion of a traffic signal at the intersection of Ward and Rumson was raised and given consideration during the Local Concept Development Bridge Study. This intersection was evaluated; however, due to the operational constraints associated with the bridge openings, the traffic signal at the Sea Bright intersection and detrimental effect on traffic flow, a traffic signal at the intersection of Rumson Road and Ward Avenue was not considered a viable improvement option.

The intersection doesn't meet warrants on amount of traffic or crashes to install a traffic light, however a pedestrian flasher will be implemented, similar to what is in place at Riverview.

The intersection will have painted roadway cross walk striping and pedestrian crossing flasher to improve safety and encourage traffic calming.

Thank you for your comments. Regarding navigational clearance, the new bridge will provide a similar clearance height to the existing bridge, which is 15-feet at Mean High Water.

There are several reasons why the height of the new bridge remains relatively the same as the height of the existing bridge. During the LCD Study phase, it was determined that there is insufficient room to raise the bridge as it would have significant impacts to properties, roadways and the intersections at both approaches.

In particular, the signalized intersection at Rumson Road and Ocean Avenue was a significant factor in determining the height of the new bridge because of its proximity. If the height of the bridge were increased then the intersection would have to be raised, consequently impacting the surrounding local streets, Sea Bright Riverfront Park, private properties, access/driveway locations and parking.

Monmouth County, in cooperation with NJTPA, NJDOT, and FHWA, will be hosting an in-person Public Information Center meeting regarding the Construction Phase for Monmouth County Rumson-Sea Bright Bridge S-32 Replacement over the Shrewsbury River located between the Borough of Rumson and Borough of Sea Bright.

October 27, 2021 Meeting in Rumson

In light of 2021 Summer rain storms in New Jersey that resulted in about 23 deaths of New Jersey residents as a result of flash floods, primarily in communities of color in Central New Jersey, we are continuing to question this Federal expenditure for a bridge where the primary road floods when it rains over 1/2 inch a day, reducing the two lane County Road to a single lane road preventing this bridge from being a viable evacuation route.

We are residents of Rumson and we've been presenting to Monmouth County and State Legislators the concern over the Federal expenditure of approximately \$140 million to replace a bridge that served by a road that while it is unlikely to flood to the level of drowning, the road is flooded to the point the probability of head on collisions will cause injury or death.

Has the County and State previously provided the flooding conditions of CR520, Rumson Road, in front of the Sea Bright Tennis Club in it's funding proposals to the FHWA and are the funding agencies aware of such flooding conditions?

As residents of Monmouth County and New Jersey, we request copies of any and all documentation that presented the flooding conditions of CR520 to the FHWA and funding agencies and authorities prior to receiving funds and funding commitments?

In addition, does the funding for the replacement bridge explicitly allocate funds for remediation of flooding on CR520, and if such funds are explicitly stated we would like to be advised as to the timeline for such remediation.

As we were advised, funds allocated by the FHWA will be diverted to remediate the flooding of CR520, without the explicit stated declaration and if such remediation is to be completed after the bridge is completed, we would like to be advised why such flood remediation can not be completed before the bridge construction begins?

While it had been the practice of Monmouth County not to present the documentation described above, it would be a preferred route to the submission of FOIA requests. Will the County reconsider making the documents relating to the funding and timeline of flood remediation of CR520 before November 15, 2021?

In response to your online submitted question regarding hours of construction operation and traffic operations, the contractor will be required to maintain construction operations during normal working hours and limited by local noise ordinances. Construction is scheduled to last approximately 42 months, with completion of the project in 2025. The contractor is required to maintain Rumson Road open at all times, and only short-term local road detours will only be implemented to complete work at the intersection of Rumson Road and North Ward Avenue. The temporary detours will be limited to minimize disruption.

Notifying the public with traffic advisories about temporary delays or detours during the bridge replacement construction will be provided via the project website. There will be continued community and public involvement efforts to maintain ongoing awareness and communication as the construction activities progress for the bridge replacement and approach roadway intersection improvements in Rumson and in Sea Bright.
